**SPONSORS AND GODPARENTS FOR INFANT BAPTISM**

#16 The sponsor or sponsors must have completed the **sixteenth year of age**, unless the pastor or minister has granted an exception for a just cause, and must be a **Catholic who has been confirmed and has already received their First Holy Communion and who leads a life of faith in keeping with the function to be taken on**. This means a sponsor may not be bound by any canonical penalty legitimately imposed or declared to be the father or mother of the one to be baptized (canon #874).

#17 **Only one sponsor is required, and the maximum number of sponsors is two, in which case they must both be Catholics, and one male and one female. A Christian Witness may be designated as such, but only if a Catholic who meets the requirements outlined above has been designated as the sponsor. A baptized person who belongs to a non-Catholic ecclesial community is not to participate except together with a Catholic sponsor and then only as a witness of the baptism (canon 874).**
